4. The tender committee evaluated the bids as per "Qualification and Evaluation Criteria" given in the tender document as under.




5. The committee has scrutinized the offer of **M/s. BMA Traders** as per tender document Term & Condition. **M/s. BMA Traders** fulfill the requirements of eligibility criteria and quoted lowest rates at **Rs. 1,151,635/=, (Rupees One Million One Hundred Fifty One Thousand Six Hundred Thirty Five Only)**.
6. That Financial and Technical Bid was evaluated by the tender committee and after having scrutinized the same, it has been found that "**M/s. BMA Traders**" fulfill the evaluation criteria as set forth in the tender document and representing value for money as per Rule 38B of Public Procurement Rules, 2004 (as amended) as follow;

Rule 38B. Single responsive bid in goods, works and services.

The procuring agency shall consider single bid in goods, works and services if it

- Meets the evaluation criteria, ensures compliance of specifications and other terms and conditions expressed in advertisement or bid solicitation documents;
 - Is not in conflict with any provision of the ordinance;
 - Conforms to the Technical specifications;
 - Has financial conformance in terms of rate reasonability
7. That procuring agency shall make a decision with due diligence and in compliance with general principles of procurement like economy, efficiency and value for money.
8. The tender committee carried out the due diligence process in order to collect and analyze information particularly in compliance of Rule – 38(B)(d) as well as bidder eligibility criteria as mentioned in the tender documents. The word "rate reasonability" implies that a rate that is not inadequate, excessive and unreasonable discriminatory. It is considered that rates quoted by the bidder are fair and reasonable.
9. On the basis of above, the tender committee unanimously recommends to award contract to **M/s. BMA Traders** at a cost of **Rs. 1,151,635/=, (Rupees One Million One Hundred Fifty One Thousand Six Hundred Thirty Five Only)**, for procurement of miscellaneous items for fabrication of gangway at marine jetty for PQA boat RHIBS.
