- iii. Conditional quotations with remarks such as "Current Market Price plus 10%" will not be considered.
- iv. Bidder should not have been blacklisted / debarred at the time of submission of Tender.
- v. Bidder shall bear all costs associated with the preparation and submission of its bid, and PNSC, in any circumstance, will not be responsible or liable for those costs.
- vi. Bidder should quote a composite price inclusive of all taxes & duties.

2. ELIGIBILITY CRITERIA FOR SELECTION OF SINGLE CLASSIFICATION SOCIETY

1. Bidder shall be member of IACS (International Association of Classification Association). And having memorandum of understanding (MOU) with Ministry of Maritime affairs Government of Pakistan
2. Subcontracting will not be allowed.

AWARDED CRITERIA

Bidder meeting the eligibility criteria, terms mentioned in the document, and having lowest evaluated cost shall be awarded the contract.

3. TRANSFER OF CLASS TO ONE CLASSIFICATION

The Bidder shall mention in proposal the detail timing of shifting of ship transfer to proposed classification free of cost.

4. SCOPE OF SERVICES:

PNSC currently have five classification societies for its entire fleet. PNSC is intending to assign/appoint Classification Society for PNSC Managed Bulker M.V Hyderabad & M.V Malakand to simplify operations of the vessels by reducing the cost and improve Safety and Reliability of vessel. The key function of Classification is to work on behalf of owner to validate and certify ship to statutory and regulatory requirements as specified by IMO and Flag State. Classification Society must undertake the following:

- Damage surveys, and surveys in connection with wear and tear repairs and Conditions of Class.
- Outstanding items for completion of any statutory/convention survey.
- Services additional to those listed in the ship schedule(s) and which are related to classification requirements, such as modifications, alterations, introduction of new rule requirements, and/or new statutory/convention requirements, such as change of flag, issue of tonnage certificates, approval of drawings/manuals, port state control inspection.
- Any special circumstances arising from attendance in respect of surveys undertaken at sea.
- Special consultancy services falling outside the requirements for classification.

A. The Financial proposal shall include the following:

- i. Lowest bid offer for complete coverage of certifications, surveys and technical assistance as specified in tender document- Mandatory.
