


4. Furthermore, the Procurement Officials visited the SEESI and EOBI departments to verify the submitted certificates. The departments confirmed that the certificates submitted by two firms, namely M/s. CAPTAIN Cleaning Services (Pvt.) Ltd. and M/s. PAKISTAN Contractor, are not valid.

5. As per the above-mentioned bidder eligibility criteria, only two (02) firms, M/s. KOLACHI Trader (Private) Limited and M/s. SELEKT Services, have been prequalified for the subject services.

6. In view of the above, the Tender Committee unanimously recommends that management approval may kindly be accorded to proceed further with M/s. KOLACHI Trader (Private) Limited and M/s. SELEKT Services, as they have been prequalified for the Procurement Of Cleaning And Janitorial Services at PNSC Building (Head Office) For One Year.
