

As per comparative statement, M/s. **GOSEA MARINE**, is the most advantageous bidder with total quoted amount of **USD:28,665.67 equivalent to PKR: 8,030,683.72** to supply spares from China with delivery time 15 days, placed opposite at Flag "G". With respect to Payment terms it may please be noted that initially at the time of bid opening lowest bidder M/s. GOSEA Marine, payment terms were 30% advance and 70% at the time of shipment. For negotiations in the payment terms, spare section contacted the supplier to convince them on 30 days credit terms. In response supplier regretted and agreed to 100% advance payment before shipment upon receipt of inspection report duly endorsed by class surveyor, email correspondence is attached.
5. Keeping in view of the above, Tender Committee unanimously recommends for the approval of **C.E.O** under clause 36 (a) Proviso 13(i) of PPRA for subject procurement from most advantageous bidder **M/s. GOSEA MARINE**. for total amount of **USD:28,665.67 equivalent to PKR: 8,030,683.72**.
